



MEMORANDUM OF UNDERSTANDING SPONSORSHIP AGREEMENT

The parties to this Memorandum of Understanding and Sponsorship Agreement are the Florida Sports Foundation (hereafter FSF) and the Florida Jr. Olympic Games LOC LLC (hereafter FLOC.)

Whereas, FLOC is the entity to which the Amateur Athletic Union has assigned the duty to manage the 2020 Jr. Olympic Games (JOG) to be held on **July 25th** at **August 8th 2020** in Florida, and;

Whereas FSF wishes to support and promote the JOG and assist FLOC in the management and operation of the JOG where appropriate and;

Whereas FLOC and FSF wish to memorialize the basic terms of their agreement regarding the JOG;


It is understood and agreed as follows:

1. FSF will provide a sponsorship/partnership fee of fifty thousand dollars (\$50,000) to FOG for operational expenses relating to joint event JOG and Sunshine State Games, to be paid on or before August 1, 2020.
2. The JOG and Sunshine State Games shall be co-branded and co-promoted by the parties. Details regarding logos and other promotional materials shall be agreed upon and no promotional materials shall be released without prior written approval of both parties.
3. The parties will cross-market the event, promoting both the JOG and Sunshine State Games.
4. FSF will oversee, run, and manage the sports of Bowling, Footgolf, and Archery, as part of the Sunshine State Games.
5. FSF will provide Sunshine State Games medals to the top 3 Floridian athletes in all sports of the JOG, and Sunshine State Games.
6. FLOC will provide Jr. Olympic Games medals to all events.

7. FSF and FLOC shall jointly develop registration details to permit athletes to register through the platform of either organization.
8. Within thirty (30) days following the conclusion of the event, FLOC shall provide to FSF a post event recap to include attendance and community impact information, event photos, screen captures, and other details highlighting the FSF FLOC partnership as listed in this agreement.
9. Force Majeure: The performance of this Agreement by either part is subject to acts of God including fire, hurricanes, earthquakes, tornadoes, floods, or extremely abnormal and excessive inclement weather; government authority; disaster; strikes; civil disorders; a declared pandemic; quarantine restrictions; or emergencies, any of which make it illegal or impossible to provide the facilities and/or services for this event. This specifically includes but not limited to a declared public health emergency or state emergency in Florida, whether related to COVID-19 or not, mandatory or recommended quarantine or stay-at-home restrictions, or mandatory prohibitions on public gatherings of 100 people or more in effect in Florida within fifteen (15) days prior to arrival. This also includes but is not limited to any emergency that makes travel by flight to Florida illegal or inadvisable based on guides from Florida or the CDC, guidance which is issued within fifteen (15) days prior to arrival.


